BE IT REMEMBERED THAT A SPECIAL MEETING OF THE GREENWOOD CITY COUNCIL was held this Tuesday, May 8, 2012 at 4:00 p.m. in the Council Chambers of the Greenwood City Hall, it being the time and place for holding said meeting.

There were present at this meeting, Mayor Carolyn McAdams, Attorney Don Brock, Jr., Councilpersons Johnny Jennings, Lisa Cookston, Ronnie Stevenson, and David Jordan, and Cinderella Morris, Council Clerk. Councilpersons Charles E. McCoy, Sr., Tennill Cannon, and Carl Palmer being absent.

Also present was: Angela Curry, Executive Director of Greenwood Leflore Industrial Board and the Greenwood Leflore Carroll Economic Development Foundation.

Motion was made by Councilperson Johnny Jennings, seconded by Councilperson Lisa Cookston to adopt the agenda. A vote was taken, Councilpersons Johnny Jennings, Lisa Cookston, Ronnie Stevenson, and David Jordan all voted YEA. Councilpersons Charles E. McCoy, Sr., Tennill Cannon, and Carl Palmer being absent. The President declared the motion passed and adopted.

Angela Curry, Executive Director of Greenwood Leflore Industrial Board and the Greenwood Leflore Carroll Economic Development Foundation, thanked the Council for calling the special meeting today and for entertaining the proposal from Atmos Energy. She explained the following resolution to the Council. She said the cost of the project is \$738,146.00. She stated that Atmos Energy will absorb \$383,145.00, leaving a balance of \$355,000.00. She said that Leflore County had agreed to share one half of the cost. She asked the City to share the other half of the cost, which amounts to \$102,500.00 each from the County and the City. Council discussed this further.
