She said the foundation has 5 ½ acres of land to build a permanent home for the foundation in Ruleville, the hometown of Fannie Lou Hamer. She said a half acre of property was donated by the descendants of the Marlow family that put Ms. Hamer off the plantation when she dared to vote.

Mayor McAdams advised Council that our sales tax allocation for the month was \$383,605.00, a decrease of \$17,731.00 or 6%. She said for the year we have collected \$2,734,787.00, an increase of \$163,733.00.

Mayor McAdams said that Brantley Snipes will make an announcement at this time. Brantley Snipes announced that Que on the Yazoo is May 5 and 6. She handed out a card advertising the event with information on the back if interested in judging Friday night May 5 to email Becky Palmer at <u>beckypalmer@cableone.net</u>. She invited Council and Mayor McAdams to attend Que on the Yazoo. She said there will be music on Friday night. She advised Council to get their t-shirt sizes to Cinderella. Mayor McAdams recognized the employees of the month for April. Director of the Waste Water Treatment Plant Division Eddie Curry presented a Certificate of Appreciation to Leonard Lofton. Fire Battalion Chief Willie Coker presented a Certificate of Appreciation to Marvin Turner. Police Chief Ray Moore presented a Certificate of Appreciation to Officer Melvin Washington. Mayor McAdams congratulated each recipient.

Mayor McAdams said that Carl Winters has an announcement for the Baptist Town Community to make at this time. Carl Winters invited the Mayor and Council to meet at Hoover's Grocery in Baptist Town to help with the Baptist Town Clean Up event to be held on Saturday, April 22, 2017 from 9:00 a.m. until noon. He said they have gloves and that refreshments will be served. He said the public is invited too.

Mayor McAdams advised Council that the Recodification Ordinance is on the study agenda today. She said it will be adopted on May 3, 2017.

Mayor McAdams said that Rail Spike Park is completed. She said she is waiting on the final inspection from MDOT (Mississippi Department of Transportation). She said she will let Council know when MDOT will be in town.

Councilperson David Jordan advised Mayor McAdams that no play equipment was in Martin Luther King Park. Mayor McAdams said she will get with the Park Commission regarding this matter.

Council President Ronnie Stevenson advised Council that he made a legislative decision changing the May 2, 2017 meeting to May 3, 2017. He also advised Council that June 6, 2017 is Election Day and that they need to change it. Council discussed this further and agreed to change the meeting dates of the May 2 and June 6 Dilapidated Housing meetings.

He said the group has worked to provide housing for the homeless and to repair and replace decaying housing in Memphis. He said he looks forward to working with the city. He said they have been successful in securing federal and state grant money and that they are also looking at ways to create private-public partnerships and collaborations to bring together people working for similar goals.
