IN RE: MAYOR'S REPORT

Mayor McAdams congratulated the Council on their win in the June 6, 2017 election.

Mayor McAdams said she had some sad news today. She asked Bob Darden to come forward at this time. Bob Darden announced that today is his last council meeting with the Council. He said he is leaving on June 10th. He said he enjoyed working with the Council and that his replacement, Lauren Randall, will start on the 12th. He said that he has 17 ½ years with the newspaper. Mayor and Council presented Bob Darden with a fruit basket as a token of appreciation from the city.

Councilperson David Jordan addressed his concerns about illegal dumping in various areas in the city. He asked if the Police Department could place “No Dumping” signs with fine amount on them in areas where illegal dumping is occurring regularly. Mayor McAdams said she agreed with Councilperson Jordan 100 percent. She said the city has been working on illegal dumping by putting up surveillance cameras and putting out some signs around the city. She said that the fines and penalties need to be increased to discourage the dumping. She also stated that people need to stop emptying out their entire homes on the city’s streets. Council discussed this matter further. Public Works Director Susan Bailey said she could coordinate the placement of the signs in the city.

Police Chief Ray Moore congratulated the Mayor and Council on their wins. He introduced Officer Terrance Foreman, one of his new officers, to the Council. He said that Officer Foreman has been with his department for two months.
