IN RE: MAYOR'S REPORT

He stated that our sales tax allocation for this month was \$375,540.00, an increase of \$4,334.00 or 1% more than May, 2016. He said for the year we have collected \$3,559,758.00, an increase of \$218,317.00 or 6.5% more than this time last year.

Council President Ronnie Stevenson read a Thank You card from Bob Darden thanking the Mayor and Council for the thoughtful fruit basket that they presented him with at his last meeting of the Council. He said that Bob said that he considered each of them a friend and that he truly believes that Greenwood's best days are ahead.
