GREENWOOD CITY COUNCIL was held this Tuesday, August 1, 2017 at 4:00 p.m. in the Council Chamber of the Greenwood City Hall, it being the time and place for holding said meeting.

There were present at this meeting, Mayor Carolyn McAdams, Attorney Don Brock, Jr., Councilpersons Lisa Cookston, Ronnie Stevenson, Andrew Powell, David Jordan, and Carl Palmer, Thomas Gregory, III, CAO; Nick Joseph, Jr., City Clerk, and Cinderella M. Morris, Clerk of the Council. Councilpersons Johnny Jennings and Charles E. McCoy, Sr. being absent.

Also present were: Linda F. Perkins, Cameron Abel, David Williams, Micheal Shanklin, Russell B. Robinson, Main Street Greenwood Director Brantley Snipes, Alliyah Sims, Delta News, Eric Spencer, Lauren Randall, Commonwealth Newspaper and Chris Williams, Taxpayers Channel.

The President declared the motion passed and adopted.

IN RE: MAYOR'S REPORT

Mayor McAdams stated that she missed the last meeting and then she went to the MML. She said the speakers and the training were great at the MML.

Mayor McAdams recognized the employees of the month for July. Assistant Fire Chief John Lewis presented a Certificate of Appreciation to Captain Marvin Turner. Fire Chief Marcus Banks recognized Assistant Fire Chief John Lewis and Battalion Chief Willie Coker for their 38 years of service to the fire department. He said he has 200 years of command service in his department. Public Works Director Susan Bailey presented a Certificate of Appreciation to Roosevelt Scott. Police Chief Ray Moore presented a Certificate of Appreciation to Farrah Chandler.

Mayor McAdams said that Brantley Snipes will speak at this time. Brantley Snipes advised Council about a new downtown retail campaign going on now through August 30, 2017. She said that customers who purchase from any downtown retail location will automatically be entered into a drawing for a one night stay at the Alluvian and a Viking Cooking School class. She also said that Main Street Greenwood will hold a downtown development workshop on August 30, 2017 for potential or current downtown property owners. She said the location has not been determined yet.

Councilperson David Jordan announced that State Treasurer Lynn Fitch will be in Greenwood tomorrow at the Voters League at 7:00 p.m. He said everyone is invited.

Mayor McAdams said that Nick Joseph has given her some preliminary numbers for budget. She said she would like to meet next Wednesday or Thursday for a budget review workshop. Council agreed to meet Wednesday, August 9, 2017 at 4:30 p.m.

Mayor McAdams announced that Thomas Gregory is leaving the city after eight years. She presented him with a farewell plaque for his years of service to the City of Greenwood. Councilperson Charles McCoy presented Thomas with a token from his family.

Thomas Gregory stated that he had accepted a job with Carl Small Town Center at Mississippi State as the community planner and that he starts his new job on August 16, 2017. He said his last day with the city is August 11, 2017. He thanked the Council and the citizens of Greenwood for the support they gave him over the past eight years. He said it has been an honor to work for the city that he calls home. He thanked Mayor McAdams for her trust and guidance over the years. He said the opportunity came unexpectedly. He stated that Greenwood's best and brightest days are ahead.

Councilperson David Jordan advised President Stevenson that there was a person here that wants to open up a barbershop. Betty Stigler advised Council that a barbershop was not allowed in that district. Micheal Shanklin addressed the Council stating that before he purchased the property for the barbershop he contacted the Community Development Office regarding the property being commercial. Betty Stigler and Victor Stokes spoke on this matter.

Linda Perkins along with Cameron Abel addressed the Council regarding the Greenwood Little Theatre. Linda Perkins stated that last year she appeared before the Council regarding the Renaissance. She said she is appreciative of the part the Council played. She asked the Council for additional funding for a wooden fence to separate the building from the property next door, work on the outside of the building, landscaping and upgrade to patio for visitors, and parking lot repairs and striping.

Cameron Abel spoke about the Shakespeare Theatre Camp at the Greenwood Little Theatre. He said that Greenwood Little Theatre is the second oldest community theatre. He said that Shakespeare Summer Scene Fest will be performed Thursday, Friday and Saturday of this week at 7:00 p.m.

Linda Perkins spoke about the Greenwood Little Theatre 2017/2018 Season Brochure and the productions dates for the theatre. Mayor McAdams advised Perkins to submit her request for funding in writing.
