### IN RE: MAYOR'S REPORT

Mayor McAdams stated that we have a honored guest from the Chamber of Commerce in the gallery today. She asked Beth Stevens to introduce the guest. Beth Stevens announced that the Leadership Greenwood Class of 2017 was present. She asked each member present to introduce themselves and give their place of employment. Jonathan Grantham, Life Help, Renardo A. Hall, Mississippi Valley State University, Ruthie Robison, Greenwood Commonwealth, Scott Wynne, Southgroup, Caleb Bartlett, Bank of Commerce, C.J. Montgomery, Greenwood Fire Department and Lieutenant Jamaal Ellis, Salvation Army introduced themselves along with their employment. Beth Stevens thanked the city for the successful Bikes, Blues and Bayous event. She said there was 1100 cyclist in attendance this

year compared to 900 last year. She said that hotels and restaurants were full. She said cyclist came from twenty one different states. She further stated that this year they did surveys and had gotten 500 surveys back.

Mayor McAdams advised Council that our sales tax allocation for the month of July was \$385,443.00, an increase of \$45,166.00 or 13% more than July last year. She said for the year we have collected \$4,327,657.00, an increase of \$275,043.00 or 6.7% more than this time last year.

Mayor McAdams recognized the employees of the month for August. Fire Chief Marcus Banks presented a Certificate of Appreciation to Jason Wallace. Police Chief Ray Moore presented a Certificate of Appreciation to Mavis Cosper. Director of the Waste Water Treatment Plant Division Eddie Curry presented a Certificate of Appreciation to Stevie Wilson. Mayor McAdams congratulated each recipient.

Mayor McAdams said that Susan Bailey will introduce the new recycling coordinator employee. Susan Bailey introduced Derek Hinckley as the new recycling coordinator. Derek Hinckley said that he assisted with curbside pickup today. He said recycling is a win for businesses and citizens. He plans to help grow the recycling program. He said he looks forward to working with the Council, the Mayor and the city.

Mayor McAdams gave Council an update on grants. She said the city received three grants; Wildlife and Fisheries in the amount of \$84,991.00 for continued work on the Yazoo River Trail and the arboretum that starts in 90 days, a Healthy Heroes Grant from Blue Cross Blue Shield in the amount of \$16,875.00 to improve the Farmers Market and training of police and fire employees to deliver presentations to the elementary schools about healthy lifestyles and eating habits and a Department of Environmental Quality Grant in the amount of \$25,000.00 to purchase a forklift for the Greenwood-Leflore Recycling Center that was written by former recycling coordinator Kenya Adams.

Mayor McAdams said that she was proud of the Salvation Army in our community. She said they do great works for the city. She said the Salvation Army in Greenwood will be celebrating its 75th Anniversary August 25 - 27, 2017.
