Motion was made by Councilperson Carl Palmer, seconded by Councilperson David Jordan, to adopt the agenda. A vote was taken, Councilpersons Johnny Jennings, Lisa Cookston, Ronnie Stevenson, Charles E. McCoy, Sr., David Jordan and Carl Palmer all voted YEA. Councilperson Andrew Powell being absent. The President declared the motion passed and adopted.

The purpose of the meeting today was to provide the general public with an opportunity to comment on the taxing and spending plan incorporated in the proposed budget of the City of Greenwood for the fiscal year beginning October 1, 2017, and ending September 30, 2018.

Annie P. Washington addressed the Council to comment on the budget. She said that she was in favor of raising taxes if it is for a good cause. She said she did not have a problem with the tax increase. She said the tax increase will help with streets repairs and protection for the city's fire and police departments. She said the tax increase is needed. She said that the city had not raised taxes in eleven years and that they cannot go another eleven years.

Councilperson David Jordan questioned the Mayor regarding the amount of the millage increase for taxes. Mayor McAdams said that taxes would increase by 2 mills. Councilperson Jordan requested that the police department and streets be looked at in the new budget. Mayor McAdams stated that two years ago Council gave her a list of streets in their ward to be repaired. She said that they needed to look into a bond issue to resurface streets. There being no further discussion Council President Ronnie Stevenson declared the public hearing closed.
