IN RE: MAYOR'S REPORT

Mayor McAdams advised Council that our sales tax allocation for the month was \$381,545.00, an increase of \$6,005.00 or 2% more than this time last year. She said for the year we have collected \$3,432,862.00, a decrease of \$166,896.00 or 5% less than this time last year.

Mayor McAdams said that Eddie Curry will give an update on the Grenada Boulevard cave-in and a new cave in. Eddie Curry said that the Grenada Boulevard cave-in has been repaired. He stated that a cave-in has occurred on Browning Road in between the Life Health Building and the Family Dollar Store. He said they will evaluate the cave-in for bypass pumping. He announced that he will close the road from the Health Department to Highway 7. He said he will look at lining the other sewer pipes once this one is repaired and that he would like to see the city lining more pipes in the future. He said he will get prices for lining Grenada Boulevard and Browning Road. Council and Mayor discussed this matter further. Mayor McAdams deemed this cave-in as an emergency so repairs can be started.

Councilperson Charles E. McCoy, Sr. enters the meeting at this time.

Mayor McAdams recognized the employees of the month for June. Director of the Waste Water Treatment Plant Division Eddie Curry presented a Certificate of Appreciation to Robert Hogan. Fire Chief Marcus Banks presented a Certificate of Appreciation to Captain Jamie Simon. Police Chief Ray Moore presented a Certificate of Appreciation to Jonicia

Moore. Mayor McAdams congratulated each recipient.
