Mayor McAdams introduced the new Recycling Coordinator, C. J. Coleman. Coleman briefed Council on her background. She said that she is looking forward to working with recycling.

Mayor McAdams reminded Council of the Mayor's Pumpkins Patch, October 27, 2018 from 9:00 a.m. until 12:00 noon. She said that the pumpkins are being provided by Market Place. She thanked Cindi Long, Families First and Art Place for volunteering to decorate the pumpkins at the Mayor's Pumpkins Patch. She requested that Council attend and that they dress out.
