The President declared the motion passed and adopted.

#### **IN RE: MAYOR'S REPORT**

Mayor McAdams advised Council that a purchase order has been issued for the air conditioning unit. She said that she did not know why the air has not been fixed.

Mayor McAdams said that Dr. Mary Brown, Superintendent Greenwood Leflore Consolidated Schools District will speak at this time.

Dr. Mary Brown introduced her administrative team, Dr. Kenneth Pulley, Deputy Superintendent, Cynthia House, Chief of Federal Programs, Jeneveri Cation, Chief of Professional Development, Iris Hurt, Chief of Elementary Education, Sabrina Tanner-Moore, Chief of Alternative Schools, Likisha Coleman, Assistant Superintendent, Edshundra Gary, Chief of Early Childhood, Carissa Mayes, PBIS Specialist, Ulysses Kelly, Chief of Technology, Charles Johnson, Assistant Superintendent, Darryl Gary, Chief of Maintenance, Talece Hudson, Chief of Transportation, Dr. Mario Miller, Chief of Human Resources, Tina Nevels, New Chief of Finance, and Lachada Robie-Purnell, School Improvement Specialist. She highlighted things that they are doing in the district, arts, district wide band, district choir and a district show choir. She said that they plan to have a district football team at some point. She recognized Margaret Dean, Public Information Officer in her absence. Dr. Brown announced that at 5:30 p.m. the district will have a budget meeting this afternoon. She asked Iris Hurt to speak at this time.

Iris Hurt, Chief of Elementary Education, explained the third grade reading gate program that the district has put in place. She said that they had a meeting with key folks in the community who could help foster that program forward. She said that they are working on district and city wide campaigns. She said that she talked to Mrs. Thornhill and representatives from the public libraries and MVSU regarding reading campaigns.

Dr. Brown stated that on yesterday, one of their buses was involved in an accident on Highway 82. She said that all students and coaches are doing well. She asked that the students and coaches be kept in prayers. She advised Council that the district has identified some of the repairs needed in the schools. Charles Johnson stated that it is a 120 days process and that they are making necessary repairs and doing studies.

Dr. Brown said that the district is currently looking for certified teachers.

Dr. Mario Miller stated that he is trying to pull out all the stops to get some of the greatest talents. He said that he makes a collaborative effort to give teachers everything they need.

Dr. Brown thanked the Mayor and Council for catching on to the 20/20 Vision that the district has.

Mayor McAdams advised Council that our sales tax allocation for the month was \$396,543.00, an increase of \$14,998.00 or 4%. She said for the year we have collected \$3,487,064.00, an increase of \$48,002.00 or 1%.

Mayor McAdams said that next week they will be going to the MML Conference leaving Saturday and Sunday.

Mayor McAdams announced that the 4<sup>th</sup> of July event is Thursday afternoon.

Mayor McAdams said that she received a proclamation from the Governor allowing state offices to close Friday, July 5, 2019 in further observance of Independence Day. She said that a resolution is on the agenda for Council approval.

Mayor McAdams said that Brantley Snipes will speak at this time.

Brantley Snipes announced that Mainstreet Greenwood has received two Mainstreet Awards, Outstanding Business Recruitment and Retention Plan and Outstanding Best New Development for the Rail Spike Park. She said that 53 other communities participated.

Mayor McAdams announced that Thomas Gregory is the new State Mainstreet Coordinator. She said that she and Brantley got to interview Thomas.

Mayor said that Greg Korb will speak at this time.

Greg Korb addressed the Council regarding the scouts new Fire Exploring Program, the first one to be in operation. He said that he met with Chiefs Banks and McDowell to discuss the program. He said that it is something for kids to learn a trade. He stated that it is a good recruiting tool for the city. He said that he will be recruiting at the Boys and Girls Club tomorrow. Chief Banks said that he appreciated Greg for bringing this program to his department. He said that Tony Brown started out as an explorer. Chief McDowell said that the Boys Scout Explorer Program will be real constructive. Council President Ronnie Stevenson commended them on the program. Chief Banks thanked the Mayor and Council for their support of his department.

Mayor McAdams said that the employee picnic was a success with a great turnout. She thanked Councilman McCoy. Councilperson McCoy thanked the sponsors.
