IN RE: MAYOR'S REPORT

Mayor McAdams advised Council that our sales tax allocation for the month was \$362,565.00, an increase of \$4,155.00 or 1%. She said for the year we have collected \$4,255,619.00, an increase of \$43,182.00 or 1% more than last year

Mayor McAdams announced that Matthew Hebb, Marsy's Law for Mississippi is here today. She read the following Proclamation in support of Marsy's Law for Mississippi.



WHEREAS, Marsy's Law For Mississippi and advocacy organizations statewide are dedicated to guaranteeing victims' rights and providing a voice; and

WHEREAS,	Marsy's Law For Mississippi supporters agree victims should always be
	treated with fairness and respect throughout the criminal justice process,
	protected from the defendant, reasonably heard at public proceedings
	regarding their case, and given a voice through the process of the case; and

WHEREAS, Per the Federal Bureau of Investigation's (FBI) most recent "Crime in the United States" report, in 2015 a total of 8,254 Mississippians were the victim of Violent "Index Crimes" including: murder, rape, robbery, aggravated assault, burglary, larceny, and motor vehicle theft; and

WHEREAS, Marsy's Law for Mississippi will ensure that victim's receive the same rights that are afforded to criminals and have rights to notification of release, hearings, appropriate restitution, and the right to speak at during criminal proceedings; and

WHEREAS, Victims' Rights is a non-partisan, non-political issue, and Marsy's Law is a common sense approach to ensuring Victims' Rights

NOW THEREFORE, I, Carolyn McAdams, Mayor of the City of Greenwood, Mississippi, on behalf of myself and the Greenwood City Council, do hereby proclaim

Matthew Hebb thanked the Mayor and Council for their support of Marsy's Law. Mayor McAdams recognized Councilwoman Lisa Cookston in her absence. She said that Councilwoman Cookston was not in attendance today because her mother is sick.

Mayor McAdams said that she received a letter from MDOT to proceed on the Fulton Street Project. She said that the city is ready to take bids for the project. She said that work would be right at Christmas and shopping for retails. She wanted to delay the project until January. Council discussed this further and advised Mayor McAdams to go ahead with the bid process.

Mayor McAdams reminded Council of the Public Hearing on the FY2019-2020 Budget scheduled for Tuesday, August 27, 2019 at 5:30 p.m.

Councilperson Charles McCoy questioned Mayor McAdams about the cave-ins. Eddie Curry said that someone will be here tomorrow to put cameras in the line at Wastewater Treatment Plant. He said that he did not know how much this will cost. Curry stated that the cave-in at Golden Age should be fixed by Wednesday at a cost of \$30,000.00, which will be split between the city and Golden Age.

IN RE: PUBLIC AGENDA

Felecia Hadley, U.S. Census Bureau, Partnership Specialist, addressed the Council regarding the 2020 Census. She asked the city for its help to make sure we have an accurate census count for the 2020 Census April 1, 2020. She said that individuals can respond to the census by phone, mail or on line. She wants the city to help develop a Complete Count Committee composed of influential members of the community to work with different organizations to get an accurate census count. She said that the committee could also help promote the census data. She said that Leflore County is considered a low-response area since only 58% of the county's residents completed the 2010 Census. She said that in 2000 Census 66% of the residents completed the census. She said that she needs every business and church in Greenwood to help. She said that they have part-time jobs available that could be applied for at www.2020census.gov/jobs. Council President Ronnie Stevenson said that

a proclamation will be adopted at the next meeting.

Karan McGee, Adela Agency, addressed the Council regarding collecting fines for the city. She gave background history of the Agency. She highlighted the literature and brochure that each person had in front of them. She said that she collects for Greenwood Utilities. She said that the agency offers training to all its employees. She said that there is no fee to list. She said that the agency gives monthly reports. Mayor McAdams addressed the collection of fines for the city. She said that the new law will help the city with its fines. Councilperson McCoy recommended that Attorney Brock look at the contract that the city has with its current collection agency. McGee left two copies of her contract with Attorney Brock.

Lance Mohamed, Fred T. Neely & Company, presented a summary of the 2017-2018 Audit to the Council. He presented an unqualified and non-modified opinion that the audit was clean. He called to the Council's attention Page 18, stating that the city had \$10 Million Dollars in Revenues, spent \$12 Million Dollars, had a \$2.2 million deficit, borrowed \$977,000.00, Transfer in of \$1.6 Million Dollars. He said with those transfers factored in the General Fund had a positive net change of \$120,000.00, leading to a \$2.8 Million increase in retained earnings. He called attention to Page 21, Sewer/Solid Waste, stating that Sewage enterprise Fund had \$3.7 million in revenues for services and 4.7 million in expenditures for payroll and repairs, \$2 million in depreciation. He said that Wastewater Treatment repair is under litigation, net change \$1.2 million loss. He said that Sewer Enterprise Fund made money. He said that Solid Waste had \$1.9 million operating revenues, \$2.2 operating expenses and \$115,000 loss. He said the Solid Waste Fund was profitable. He called attention to Page 50, Listing of All debts owed by the city, General Obligation Bonds \$57 million, \$2 - 2.8 million owed by Greenwood Utilities, He said that the city still has some lead way, up to \$8 - 9 million. He called attention to Page 83, Grants, listing of all federal projects. He said that the city has a total of \$3.4 million in grants, majority Milwaukee Tool, others normal grants. He said the city had a finding for \$46 over budget in one line item and an internal control issue, Fred T Neely & Company is doing the city financial. Lance Mohamed agreed to attend the next meeting to answer questions from the Council if they had any.

Danielle Morgan thanked the Council and Mayor for their support. She said that last year was a record year and the highest tax year for the bureau. She said that they had visitors from 11 countries and 28 states. She that she received 7200 visitors request. She said that the BBB (Bikes, Blues and Bayous) won Top 20 Event from Southeast Tourism Society. She announced that the Emmitt Till Memory Project was funded and that the Film Incentive Bill is Back.

There were present at this meeting, Mayor Carolyn McAdams, Councilpersons Johnny Jennings, Lisa Cookston, Ronnie Stevenson, Charles E. McCoy, Sr., Andrew Powell, David Jordan and Carl Palmer, Kim Williams, City Clerk, and Cinderella Morris, Council Clerk.

Also present were: McLeod Meek, Edwin M. Meek, MD, Taylor Wood, Brittany Ramsey, Carter Kossman, Gerard Edic, Commonwealth Newspaper and Chris Williams, Taxpayers Channel.

Also present was: Police Chief Ray Moore.

IN RE: AGENDA

Motion was made by Councilperson Carl Palmer, seconded by Councilperson David Jordan, to adopt the agenda. A vote was taken, Councilpersons Johnny Jennings, Lisa Cookston, Ronnie Stevenson, Charles E. McCoy, Sr., Andrew Powell, David Jordan and Carl Palmer all voted YEA. The President declared the motion passed and adopted.

The purpose of the meeting today was to provide the general public with an opportunity to comment on the taxing and spending plan incorporated in the proposed budget of the City of Greenwood for the fiscal year beginning October 1, 2019, and ending September 30, 2020.

Brittany Ramsey questioned the \$2.8 million in the General Fund budget, why it is so hard to get hot mix, the purchase of the two pieces of equipment in the FY2019-2020 budget and the use of the equipment. Mayor McAdams addressed Ramsey concerns. Ramsey voiced her concerns about flooding and drainage problems on Lamar Street. Councilperson Andrew Powell addressed this issue. Mayor McAdams said that the city securing a bond for streets. Ramsey asked if citizens could apply for grants on behalf of the city. Mayor and Council discussed this further and agreed that municipalities have to apply for grants.

McLeod Meek, a rental property owner, questioned the 4% increase in taxes being added to the December 2019 tax notice. He said that he understands that the city needs to continue providing services, but he did not agree to the short notice given to the citizens. He said that he has to save each year for his taxes. Mayor McAdams told Meek that she had a conversation with Leroy Ware concerning the school consolidation and was told that the city's mill will be 44 mills, 12 mills less that than this year millage rate.

Council President Stevenson stated that he has been here 16 years and that this is the second year that he supported a tax increase.

Councilperson Johnny Jennings discussed annexation. He said that the city needs to look at ways to increase the tax base of the city. Mayor McAdams addressed Jennings concerns.

Council President Ronnie Stevenson said that the increase in taxes is all about economic development.

Carter Kossman stated that she had just bought a house and was concerned about her taxes going up. She said that the city should call a meeting concerning taxes going up.

Councilperson Charles E. McCoy said that the city has got to increase the millage rate for the best for the city.

Council President Ronnie Stevenson stated that the citizens of Greenwood get more representation from the city.

Councilperson David Jordan announced that \$5 million dollars has been set aside for tourism under Mississippi Development Authority (MDA), Senate Bill 3006.
