IN RE: BID OPENING

The purpose of this bid opening was to receive bids for the privilege of keeping all the funds of the City of Greenwood, Mississippi for a period of two years, beginning February 1, 2019.

Bids were received by Kim Williams, opened and read by Kim Williams for the following:

- (1) Regions Bank (1) Type 035 Public Funds Interest Checking accounts for accounts with a rate of .05%. Interest is paid monthly on the collected balances and statements are provided monthly. (2) CB&S Bank – Rate paid is based on actual balance within statement cycle. Variable rate at 35% of New York Prime (currently 5.50%), which would equate to a current rate of 1.925%.

(3) Planters Bank & Trust Company – Agrees to comply with Section 27-105-5 of the MS Code which mandates the State Treasury be the assigned pledgee for collateral on deposits of certain governmental units, as authorized by State Law, commonly referred to as the "Statewide Collateral Pool Program" Planters Bank & Trust Company has complied with all requirements of law and is designated as a State Depository. (6) Trustmark National Bank – Agrees to comply with Section 27-105-5 of the MS Code, which mandates the State Treasury by the assigned pledgee for collateral on deposits of certain governmental units, as authorized by State Law, commonly referred to as the "Statewide Collateral Pool Program". Trustmark is a member of the Guaranty Pool, which is an optional component of the mandate Statewide Collateral Pool Program. All terms and conditions of the Guaranty Pool will be followed according to Section 27-105-6 of the MS Code. Mayor McAdams advised Council that our sales tax allocation for the month was \$380,736.00, an increase of \$21,077.00 or 5% more than December 2018. She said for the year we have collected \$1,529,764.00, an increase of \$37,469.00 or 1.5%.

Mayor McAdams announced that the Chamber of Commerce Annual Banquet is Thursday. She said that twenty-seven restaurants will be participating in "A Taste of Greenwood".

Chief Moore explained the following resolution to the Council. He said that the City spends \$40,000 to \$50,000 for trainings and equipment for each officer. He said that state laws allows city to recoup part of the money it spends sending officers to the Law Enforcement Training Academy in Pearl. He said the statute does not provide for recovering the costs of their uniforms, equipment, on-the-job training, hiring expense, physicals, mental exams or mental test. He said that the city will be able to recoup some of the city's money back for training the officers. He stated that this policy will require officers to pay back the city for their trainings if they leave the city within three years of employment. He said a prospective hire will be informed of the policy before being hired and will be required to sign a contract agreeing to the repayment terms. Council discussed this matter further and said that it would consider adopting the same policy for the fire department.
