GREENWOOD CITY COUNCIL was held this Tuesday, June 16, 2020 at 4:00 p.m. in the Council Chamber of the Greenwood City Hall, it being the time and place for holding said meeting.

There were present at this meeting, Mayor Carolyn McAdams, Attorney Don Brock, Jr., Councilpersons Johnny Jennings, Lisa Cookston, Ronnie Stevenson, Charles E. McCoy, Sr., Andrew Powell, David Jordan, and Carl Palmer, City Clerk Kim Williams, and Council Clerk Tamira Brown.

Motion was made by Councilperson Carl Palmer, seconded by Councilperson Charles E. McCoy, Sr., to amend the agenda to include a resolution accepting a \$650,000.00 Mississippi Home Corporation Blight Elimination Program Grant. A vote was taken, Councilpersons Johnny Jennings, Lisa Cookston, Ronnie Stevenson, Charles E. McCoy, Sr., Andrew Powell, David Jordan, and Carl Palmer all voted YEA. The President declared the motion passed and adopted.

IN RE: AGENDA

Motion was made by Councilperson Carl Palmer, seconded by Councilperson David Jordan, to adopt the amended agenda. A vote was taken, Councilpersons Johnny Jennings, Lisa Cookston, Ronnie Stevenson, Charles E. McCoy, Sr., Andrew Powell, David Jordan, and Carl Palmer all voted YEA. PAYMENT OF CLAIMS AND ACCOUNTS

IT IS ORDERED that claims and accounts appearing on the Docket of Claims be allowed and paid out of the funds as shown. IN RE: MAYOR'S REPORT

Mayor McAdams welcomed everyone and stated that the Mississippi Municipal League Conference Election was cancelled due to the Corona Virus outbreak. She said all positions will stay the same until July, 2021.

Mayor McAdams gave a report on the sales tax for the month of June. She said that the sales tax allocation is \$381,256 and this is a decrease of \$15,287 or 4% for this time last year. For the year we collected \$3,482,863, which is an increase of \$1,799 or less than 1% for the year. She also stated that the City was awarded \$650,000 for the Mississippi Home Corporation Blight Elimination Program Grant.

Mayor McAdams asked that everyone be patience with the Public Works Division. The grass has gotten unruly because we are down two people with Corona Virus. Four people in total were sent home who help maintain the dilapidated property yards.

Mayor McAdams announced that Cynthia Stanciel has been working with Eddie Curry, MEMA, and FEMA on working out the application to recoup the money we have spent on the cave in, across the river, on Claiborne Street. We have spent close to \$600,000 dollars. So far it looks like the Federal Government and the State is going to help us with this money.

Councilperson Charles E. McCoy, Sr., asked about the trash not being picked up

outside of homes. Mayor McAdams responded by reminding everyone that we are one driver short and because everyone has been at home we have been having excessive amounts of trash. She explained that some people have been either evicted or have had to leave their homes and this resulted in homes being emptied out and trash put on the streets. It takes two or three trips and is very expensive to pick up all the trash.

Councilpersons Charles E. McCoy, Sr., asked Public Works Director Susan Bailey how were we coming on the trash. Susan Bailey explained that we only have three trash trucks that are running. There are five routes that cover the City and some routes are taking five days to complete and as soon as some areas are picked up, the trash is piled back again.

Mayor McAdam reminded everyone that the Corona Virus is still out there and to be mindful and respectful of others when going out.

Councilperson David Jordan has a flyer with information on it to help small business if they have lost money due to Covid-19. He also stated that Senate Bill 2772 have all counties and municipalities included in the bill. The 1.25 billion dollars in this bill will be spent to help whoever lost revenue.

Councilperson Carl Palmer recognized the brothers of Omega Psi Phi Fraternity, Inc. by asking them to stand. He said he had not seen so many in one council meeting and welcomed them for being there.

Councilperson President Ronnie Stevenson recognized Cinderella Morris and Victor Stokes for retiring. Councilperson President Ronnie Stevenson read a proclamation that thanked Cinderella Morris for the years and dedication she had put into being the Clerk of The Council. He stated that June 16, 2020 will be celebrated and observed as Cinderella Morris Day. Both Cinderella Morris and Victor Stokes were presented with a fruit basket and a key to the City.

IN RE: PUBLIC AGENDA TROY BROWN, CONFEDERATE MONUMENT – WANTS THE COUNCIL SUPPORT IN HAVING IT MOVED TO THE MUSEUM

Troy Brown, Sr. alongside Troy Brown, Jr. addressed the council wanting a resolution done and the Council's support in moving the Confederate Monument from in front of the Courthouse to a museum. Troy Brown, Sr. said that the monument represents and embodies everything we are trying to get away from. Troy Brown, Jr. expressed that when the monument was erected in 1918 it wasn't meant to show a sense of pride for the south nor was it made to be a memorial to vets. Councilperson David Jordan advised Troy Brown, Sr. and Troy Brown, Jr., to address the Board of Supervisors about this matter. Councilperson President Ronnie Stevenson thanked them for sharing their concerns and stated that the council would work on a resolution in support of moving the monument.

Jessie Stewart addressed the Council about a tree that had fallen on his car. He asked Council President Ronnie Stevenson was it the citizens job to let the Council know about rotten trees. Mayor McAdams gave Jessie Stewart a brief about how the insurance claim policy procedure works. Mayor McAdams advised Jessie Stewart to come see her in the morning to discuss the issue along with all other parties involved.
