**GREENWOOD CITY COUNCIL** was held this Tuesday, May 5, 2020 at 4:00 p.m. via Zoom Meeting by calling 1-312-626-6799 and entering the Meeting ID: 825 502 8436 and posted on Carolyn McAdams Facebook Page, it being the time and place for holding said meeting.

There were present at this meeting, Mayor Carolyn McAdams, Attorney Don Brock, Jr., Councilpersons Lisa Cookston, Ronnie Stevenson, Charles E. McCoy, Sr., Andrew Powell, and David Jordan, Cynthia Stanciel, CAO; Kim Williams, City Clerk and Cinderella Morris, Council Clerk. Councilpersons Johnny Jennings and Carl Palmer being absent.

Also present was: Rev. Peter Gray.

Also present were: Public Works Director Susan Bailey and Code Enforcement Officer Betty Stigler.

Council President Ronnie Stevenson advised Council that they have a resolution that they need to add to the agenda, therefore they will need to amend the agenda. Councilperson Charles McCoy asked President Stevenson what were the Council adding to the agenda. President Stevenson advised Councilperson McCoy that he will let Attorney Brock explain that to him. President Stevenson said that it has something to do with the Veteran Grant that they are doing for Judge Carlos Palmer.

Council President Ronnie Stevenson announced that he was going to do a roll call of all the City Council. Ward 1 Johnny Jennings, Ward 2 Lisa Cookston present, Ward 3 Ronnie Stevenson present, Ward 4 Charles McCoy present, Ward 5 Andrew Powell present, Ward 6 Senator David Jordan present, Ward 7 Councilman Carl Palmer.

Council President Ronnie Stevenson announced that we have with us today Rev. Peter Gray who is leaving the city for a better position. He said that Rev. Gray will lead us in prayer today.

Rev. Peter Gray thanked the Mayor and Council for their leadership and support. He presented the prayer for the meeting today.

Mayor McAdams told Rev. Gray that she would like to say on a personal level "thank you so much" for always accepting the call to give us prayer at our city council meetings. She said that Rev. Gray has been there for most of their swearing ins. She said that Rev. Gray and Rev. Collins have been there through thick and thin. She said that she appreciated his leadership and support for our community especially with Mission Mississippi. She wished him the very best as he goes to Swaynee.

#### IN RE: AGENDA

Motion was made by Councilperson David Jordan, seconded by Councilperson Charles E. McCoy, Sr., to amend the agenda to include an Amended resolution authorizing the City of Greenwood Municipal Intervention Court to apply for and to accept an Adult Drug Court and Veterans Treatment Court Discretionary Grant and authorizing payment of \$5,000.00 for grant application preparation. A vote was taken, Councilpersons Lisa Cookston, Ronnie Stevenson, Charles E. McCoy, Sr., Andrew Powell and David Jordan all voted YEA. Councilpersons Johnny Jennings and Carl Palmer being absent. The President declared the motion passed and adopted.

#### IN RE: AGENDA

Motion was made by Councilperson David Jordan, seconded by Councilperson Charles E. McCoy, Sr., to adopt the amended agenda. A vote was taken, Councilpersons Lisa Cookston, Ronnie Stevenson, Charles E. McCoy, Sr., Andrew Powell and David Jordan all voted YEA. Councilpersons Johnny Jennings and Carl Palmer being absent. The President declared the motion passed and adopted.

#### PAYMENT OF CLAIMS AND ACCOUNTS

IT IS ORDERED that claims and accounts appearing on the Docket of Claims be allowed and paid out of the funds as shown. That said Claims appearing in Claims Docket Book 66, and evidenced by Claims Numbers 5121 through 5217 inclusive, be paid by Check Numbers 12370 through 12381 inclusive, and Check Numbers 12383 through 12466 inclusive, and said claims and accounts being made a part of the minutes as though fully copied herein.

Council President Ronnie Stevenson announced that the second meeting for this month may still be on Zoom. He said if it was alright with the Council, he was going to try and do his best to find a way to have their first meeting in June back in the Council Chamber.

#### IN RE: MAYOR'S REPORT

Mayor McAdams said that she was with President Stevenson in that she is hoping they could get back in the Council Chamber so they no longer have to do these meetings by Zoom.

Mayor McAdams said that she has a proclamation to pay tribute to Municipal Clerks. She said that she has a proclamation in front of her that May 3 – 9, 2020 is "Municipal Clerks Week". She said that she was not going to read all of it but wanted to make sure that people understand that the city clerks have a huge heavy responsibility. She said that the clerks continually strive to improve the administration of the affairs of the Office of the Municipal Clerk through participation in education programs, seminars, workshops and the annual meetings of their state, province, county and international professional organizations. She said that they recognize the accomplishments of the Office of the Municipal Clerk and recognize that without them the city could not do most of its business being that they do every financial transaction that the city has to make. She asked the Council to give a round of applause, wave or something to the clerks.

Mayor McAdams thanked Beth Stevens and the Chamber of Commerce staff and board for doing a stella job with keeping the businesses updated, keeping up with and addressing their concerns and helping them through some of the small business loans.

Mayor McAdams announced that the city has two of its employees that will be retiring from the city, Cinderella Morris, who will be retiring as Clerk of the Clerk. She said that Cinderella has written a very nice letter to the Council and Mayor, which she read. She told Cinderella that they thanked her and that she has been wonderful. She said that they appreciated Cinderella and wish her the very best. She said at some point she hopes to give Cinderella and their second employee Victor Stokes who has been the Fire Marshal and City Code Inspector a proper send-off. She said right now it is hard to replace their positions because of the COVID-19 virus. She said that she thinks that they are going to take a new approach on this. She told Council that she wants them to think about how Cinderella's position is going to be replaced.

Councilperson David Jordan said that he had not met any person that was more humble than Victor Stokes and Cinderella Morris. He said that they will be greatly missed because they were always on the ball and always asking what they needed. He said that he don't know how at this very time that they will find people who would work so diligently for the city answering mistakes that the Council did not know that they made in so many instances. He said that they were losing a great team of persons who have served the city well.

Council President Ronnie Stevenson said that they might not get to see them before they retire, but that he is hoping both of their schedules would permit them to come back to a council meeting once they are back in the chamber so they could recognize all that they have done for the city.

Mayor McAdams told Council that Victor Stokes held the Fire Marshal job. She asked Council to consider moving the Fire Marshal position back under the Fire Department. She said that she would have that request in the form of a resolution.

Mayor McAdams told Council that she wanted them to think about the city's curfew that has been starting at 9:00 p.m. because of the new guidelines that the Governor came up with under the "Safer at Home Order". She said that he has lifted up some of those orders and has given some privileges. She said that the Governor's order starts at 10:00 p.m. She said that she wanted to extend the city's curfew to 10:00 p.m. giving an extra hour to people that have service available by take outs. She asked Attorney Brock if the city could vote on the change to extend the order to put it into place. Attorney Brock said that it could be done with a motion to amend that standing order to extend the curfew to 10:00 o'clock.

Councilperson Carl Palmer enters the meeting at this time.

Councilperson Carl Palmer advised Council President Ronnie Stevenson that he has had a hard time getting in on the meeting. He said that it kept cutting him out of the meeting.

Motion was made by Councilperson Andrew Powell, seconded by Councilperson Charles E. McCoy, Sr., to amend the standing order to extend the curfew to 10:00 o'clock until the next meeting on May 19<sup>th</sup>. A vote was taken, Councilpersons Lisa Cookston, Ronnie Stevenson, Charles E. McCoy, Sr., Andrew Powell, David Jordan and Carl Palmer all voted YEA. Councilperson Johnny Jennings being absent. The President declared the motion passed and adopted.

Councilperson Charles McCoy questioned the Mayor regarding the Fire Marshal position since Victor Stokes is retiring June 1st. Mayor McAdams said that the city will not have a fire marshal. She said that Chief Banks could act in that capacity until they get someone hired. Mayor and Council discussed this further.

Council President Ronnie Stevenson said that he had a conversation with the Mayor earlier and due to everything that is going on he stated that it is difficult to do any hiring right now. He said that a lot of municipalities are doing layoffs and furloughs. He said that the city is not having to layoff or furlough anybody or doing anything towards hiring. He said that he thinks all hiring should be postponed with the virus that is going on and being that they don't know what the sales tax gone be like the next couple of months.

Mayor McAdams said that she agrees with President Stevenson. She said that she had a discussion with Susan Bailey who is down some employees. She said that it might be that the city has to wait on trash being picked up. She said that they will just look at the city's revenues for the next three months. She said that some of these care packages do not touch Greenwood.

Councilperson David Jordan told Mayor McAdams that the Legislature is being called back in session Thursday by the Lieutenant Governor where they will be discussing some things. He said talked about Senate Bill 2772. He said that they moved some money around in the package for municipalities.

Mayor McAdams advised Council that on yesterday Karl Grubbs had sent each of them a list of streets and prices per their wards. She said that all wards were over except for Ward 5. She told the rest of the Council that they need to go back and make some adjustments to their list to get down to \$800,000 plus.

Mayor McAdams said that the Governor's Order is on the city's website <a href="https://www.cityofgreenwood.org">www.cityofgreenwood.org</a>, Mayor Carolyn McAdams Facebook page and the Chamber of Commerce Facebook page and website. She said that Governor Reeves has relaxed some of the businesses in reopening softly which she is appreciative of. She said the pandemic is still here and that our numbers are still climbing as of today with 175 cases and 18 deaths. She said that the responsibility of reopening will be on business owners. She said the order is still in effect with relaxing and reopening. She gave Council a highlight of the Governor's order for restaurants, bars, parks, and outdoors recreational activities.

Mayor McAdams announced that the city's parks will be open. She said that you can practice for baseball. She recommended that parents not be encouraged to attend due to social distancing.

Mayor McAdams announced that bars, gyms, beauty shops and barber shops will remain closed until further notice.

Mayor McAdams said that the city will not have a summer program this year due to expense and trying to control the COVID-19 spread. She said that the city also will not open the swimming pool this summer for that exact reason. She said that the city's lifeguards need their recertification. She said that Mississippi State University and Delta State University are closed.
