### IN RE: MAYOR'S REPORT

Mayor McAdams advised Council that our sales tax allocation for the month was \$385,273.00, a decrease of \$811.00 or less than 1%. She said for the year we have collected \$778,736.00, an increase of \$6,766.00 from this time last year.

Mayor McAdams said that she will be leaving in the morning going to a National League of Cities City Summit in San Antonio, Texas until Saturday. She said that she could be reached on her cellphone.

Mayor McAdams announced that the city will be closed November 28th and 29th for the Thanksgiving Holiday. She advised citizens to look in the paper for garbage pickup schedules.

Mayor McAdams asked Chief Moore to speak at this time regarding retiring.

Police Chief Ray Moore announced that due to medical issues, he is unable to continue to serve the people of this great city as their Chief of Police at the capacity he felt they deserve. He extended a special thanks to Mayor McAdams for her concern and compassion during their discussion of his condition. He announced his pending retirement and extended his heartfelt thanks and gratitude to the Mayor and Council for their support, faith and confidence over the years. He said that he had discussed with the Mayor that he would be

Lieutenant Jason McMullin, Salvation Army, thanked everyone for the donations so far. He said that the Salvation Army is attempting to collect \$80,000 in donations during the holiday season. He said that the money collected is used for Christmas and the entire year helping the needy.

Councilpersons Charles McCoy and David Jordan made donation to the Salvation Army Kettle Drive.

Councilperson Charles McCoy challenged each Councilperson to donate \$100 towards the Cross Project. He requested that they bring their check to the next meeting.

Jim Phillips asked Mayor McAdams about the Homeless Shelter he had read about in the paper. Mayor McAdams said that the City and the County owns the building and that they are working with the Salvation Army to run the shelter. Phillips said that he wants it to go on the record that North Greenwood Baptist Church will make a \$25,000 pledge to the shelter.

Council President Ronnie Stevenson allowed Chief Ray Moore to introduce his guest. Police Chief Ray Moore introduced his wife, Jackie Moore and her sister Barbara Corbett, who were in attendance to the Council.
