The applicant shall provide reasonable time to supplement the application.

ADDITIONAL INFORMATION

All mobile food vendors must adhere to the requirements and regulations stated in the Ordinance Regulating Mobile Food Vending adopted/amended by the Greenwood City Council on October 5, 2023, in the Code of Ordinances of the City of Greenwood, Mississippi.

All individuals conducting a mobile food vending service within the City Limits of Greenwood must plainly display the permit on the mobile food vending vehicle or equipment where it may be readily seen by any City Official, Law Enforcement Officer or other Regulatory Official, and by any person or customer approaching the vendor's vehicle or mobile food vending equipment.
